Attendance at the Meeting

1. Only shareholders on record at the close of business on 14 May, 2025, the date fixed by the Directors as the record date, are entitled to receive notice of the annual meeting.
2. A shareholder entitled to attend and vote at the Annual Meeting is entitled to appoint a proxy or proxies, or one or more alternate proxies to attend and act at the meeting in the manner and to the extent authorised by the proxy and with the authority conferred by the proxy. A proxy need not be a shareholder.
3. A shareholder who is a body corporate, may, in lieu of appointing a proxy, authorise an individual by resolution of its directors or governing body to represent it at the Annual Meeting.

A final dividend of \$0.79 declared for the financial year ended 31 December, 2024 will be payable on 24 June, 2025 to shareholders on record at the close of business on 13 June, 2025.
